Staff and volunteers provide a comfortable setting to visit with others and offer referrals to medical, dental, and social services, as well as help with translating legal and other documents.</p> <p>FEEDING THE HUNGRY Over 25 tons of food were distributed to men and children through Puente's monthly partnership with the Second Harvest Food Bank.
